

## Instructions to Authors (Download PDF)

The Proceedings of AMF will be published in the **Journal "Ferroelectrics"** by Taylor & Francis Group. The articles submitted to Ferroelectrics will be published free of charge. Then, AMF attendees of IFAAP are highly recommended to submit the manuscript of proceedings according to the instruction as follows. All articles will be refereed prior to publication. As far as possible, refereeing will be carried out on site at the conference, with any changes requested being returned to the authors before the close of the conference.

### Submission of Manuscripts:

- The manuscripts should be prepared using MS Word and also generated as a pdf file.
- **Please submit two hard copies of the complete manuscript and a soft copy of all files, including separate files for each figure, on a CD-ROM or a USB memory stick, to the AMF publications desk at the conference venue by 6 pm on Monday 28th May, 2018.**
- Please fill out a **Submission Form** and attached this form with other manuscripts and materials.
- Each manuscript must be accompanied by a **manuscript transmittal form** and a Taylor and Francis **copyright form**; a copy of each is attached in the PDF file of this instruction. Authors are responsible for obtaining permission to reproduce copyrighted material from other sources and are required to sign an agreement for the transfer of copyright to the publisher. All accepted manuscripts, artwork, and photographs become the property of the publisher.

### Instructions for Manuscript Preparation

All parts of the manuscript should be typewritten, double-spaced, with one-inch margins on all sides, and all pages should be numbered consecutively. Figures should be saved separately from the text. The main document should be Text should appear in 12-point Times New Roman or other common 12-point font. Authors should also supply a shortened version of the title suitable for the running head, not exceeding 50 character spaces. Each article should be summarized in an abstract of not more than 100 words. Avoid abbreviations, diagrams, and reference to the text.

## Checklist: what to include

### 1. Author details.

Please include all authors' full names, affiliations, postal addresses, and email addresses on the cover page. Where appropriate, please also include ORCiDs and social media handles (Facebook, Twitter or LinkedIn). One author will need to be identified as the corresponding author, with their email address normally displayed in the published article. Authors' affiliations are the affiliations where the research was conducted. If any of the named co-authors moves affiliation during the peer-review process, the new affiliation can be given as a footnote. Please note that authorship may not be changed after acceptance. Also, no changes to affiliation can be made after your paper is accepted. Read more on authorship [here](#).

### 2. Abstract.

This summary of your article is normally no longer than 100 words. Read tips on writing your abstract.

### 3. Keywords.

Keywords are the terms that are most important to the article and should be terms readers may use to search. Authors should provide 3 to 5 keywords. Please read our page about making your article more discoverable for recommendations on title choice and search engine optimization.

### 4. Funding details.

Please supply all details required by your funding and grant-awarding bodies.

### 5. Disclosure statement.

With a disclosure statement you acknowledge any financial interest or benefit that has arisen from the direct applications of your research. Further guidance, please see our page on what is a conflict of interest and how to disclose it.

### 6. Supplemental online material.

Supplemental material can be a video, dataset, fileset, sound file, or anything else which supports (and is pertinent to) your paper. Supplemental material must be submitted for review upon paper submission. Additional text sections are normally not considered supplemental material. We publish supplemental material online via Figshare.

### 7. Figures.

Figures should be high quality (600 dpi for black & white art and 300 dpi for color). Figures should be saved as TIFF, PostScript or EPS files. Figures embedded in your text may not be able to be used in final production.

## 8. Tables.

Please supply editable table files. We recommend including simple tables at the end of your manuscript, or submitting a separate file with tables.

## 9. Equations.

If you are submitting your manuscript as a Word document, please ensure that equations are editable. Please see our page on mathematical symbols and equations for more information.

## 10. References

Identify references in the text by arabic numerals in brackets, and number consecutively in the Reference Section in order of their first mention. References should include: names of all contributing authors (last names first); title of article; title of journal (abbreviate according to the style of Index Medicus) or book; volume number; location and name of publishing company (books only); inclusive pages; year of publication. Examples:

Journal: Freund PA: Ethical problems in human experimentation. N Engl J Med. 1965;273:687-692.

Book: Hill AB: Statistical Methods in Clinical and Preventative Medicine. New York: Oxford University Press; 1962.

Chapter in a Book: Woolner LB: Recent advances in pulmonary cytology: Early detection and localization of occult lung cancer in symptomless males. In: Koss LG, Coleman DV, eds. Advances in Clinical Cytology. London: Butterworths; 1981:95-135.

Please note that Ferroelectrics uses CrossCheck™ software to screen papers for unoriginal material. By submitting your paper to Ferroelectrics you are agreeing to any necessary originality checks your paper may have to undergo during the peer review and production processes.
